

2022 UPDATE

The Endowment Board oversees the General Endowment and Named Endowed Funds. Combined, these funds produce approximately \$250,000 in annual revenue to support ministry and mission. We celebrate the faithfulness of those whose generosity makes possible the tremendous positive impact these funds make.

General Endowment

The purpose of the General Endowment Fund is stated in church conference resolutions originally adopted December 11, 1995, and updated July 23, 2018. The purpose of the General Endowment is “to generate a fund or funds for use by this congregation to meet ministry and mission needs not included in the operating budget,” and “to provide a continuous educational program to encourage and inform our membership of the opportunities for endowment giving through donations, bequests, memorial and gifts.”

In 2021, our General Endowment generated \$147,635 for uses aligned with this purpose. This was combined with \$13,191 in carryover from 2020 to make a total of \$160,826 available for funding programs and projects supplemental to those supported by the congregation’s ministry plan (operating) budget.

The Endowment Board receives and considers grant requests from various ministry areas. In 2021, two major general endowment grants were awarded: a \$50,000 grant for the

purchase of a new church van (which is on order), and \$62,000 to support the work of our 200th anniversary committee. Additional funding was provided for hybrid meeting technology (including OWL cameras, laptops, and monitors), podcast equipment, and bunk bed construction at an orphanage in Haiti (in honor of Carl Price). A total of \$148,598 was expended or committed. \$18,820 in funding was carried over to 2022 (some of this was from grant funds awarded and not expended or obligated).

In 2022, the Endowment Board started the year with \$182,313 available to support ministry and mission (\$163,493 in “new” funds and \$18,820 in carryover). Meeting in February, the Endowment Board approved two grant requests for 2022: 1) to support the IXOYC (High School) Choir England Trip in Summer 2022 and 2) to support Desert Sisters Retreats in 2022 and 2023. The Endowment Board meets five times per year and looks forward to funding additional requests as the year progresses. For information on Endowment Board meeting dates and guidance on how to prepare a grant request, contact Pastor Shawn.

Named Endowed Funds

In addition to our General Endowment, we are fortunate to have thirteen active named endowed funds (and two additional named funds that have been established but are not yet active). These named funds were established

with significant gifts to support designated purposes. Their uses are restricted to the purposes articulated in the agreements establishing the funds.

At the beginning of each calendar year, the appropriate committee chairpersons and staff members responsible for ministry areas able to use revenue from named funds are notified of the funding available to them for the year. This funding is available to support any programs or projects that fall within the purpose of the fund. In 2021, named funds generated \$79,006 for ministry and mission; \$90,318 is available in 2022 from named funds. Committee chairpersons and staff members with oversight of ministry areas able to use these funds have been notified of their availability and are now making plans to put them to work, making God's love real.





Expenditures from these funds are restricted to programs and projects that align with each fund's purpose. In 2021, named funds generated \$79,006 for ministry and mission; \$90,318 is available in 2022 from named funds. DONOR PROFILE

JOAN AND DWIGHT BENNER

Joan and Dwight Benner met when Dwight helped Joan unload her car when she arrived at Garrett Evangelical Theological Seminary (GETS), where Dwight would earn his Master of Divinity Degree (and later a Doctor of Ministry Degree) and Joan would earn a Master of Arts Degree in Christian Education in a cooperative program with Northwestern University. Dwight served as a pastor in United Methodist churches for 14 years and then earned a degree in computer information systems. It was Dwight's career change that brought Joan and Dwight to the Detroit area, where they joined our congregation in 1983.

Joan grew up in a small church in northern Michigan. After she graduated from college, Joan taught in the Grand Rapids area and joined Grand Rapids First United Methodist Church. When she went to GETS, Joan received funding support from an endowed fund at Grand Rapids First UMC. She knows firsthand how legacy giving can positively impact generations yet to come.

Joan worked at Birmingham First for twenty-six years, beginning as the computer coordinator and then working as the financial administrator. When asked what about her work was most fulfilling, Joan's response was, "Seeing the faithfulness of our people." She continued, "The commitment our members have to faithfully support the work of God through the church is tremendous. It was not necessarily the size of the gifts, but the commitment behind each gift, and the consistency with which people offered their support."


In September 2015, Dwight Benner was killed tragically while he and Joan were



traveling in the state of Washington. In the aftermath of this unimaginable tragedy, Joan was cared for by a host of people, including the local United Methodist church pastor in Washington. As Joan said, "I was cared for, loved, welcomed, and supported in ways that I could not have imagined. I really experienced church – this church and the wider church – when I needed it most."

In Dwight and Joan's estate plan, they committed 5% to Birmingham First and 5% to Garrett Evangelical Seminary. It's a commitment that Joan has affirmed in the aftermath of Dwight's death. Their commitment is a statement of faith in God and God's work through Birmingham First. Joan's hope for our church is that we will continue to change to meet the challenges of each new day. She is confident that "the church will be faithful to be at work in the world, where all people can participate, and we meet the needs of those who look to us."

Thanks be to God for Dwight and Joan and their faithfulness, yesterday, today, tomorrow, and into the future.



WE ARE CALLED!

“And we know that in all things God works for the good of those who love him, who have been called according to his purpose.”

Romans 8:28

The Church is the community of faithful that have been called in Jesus Christ; called to God’s very side as we seek to live at the side of those who need us most; that they might know they are not alone.

But imagine for a moment what would happen if we chose not to answer our call. What would happen for Afghan refugees if we chose not to answer the call to stand at their side in this time of great need? What would happen for the guests of Cass Community Social Services if we chose not to answer the call when they needed us most? What would happen if we just simply went back home each week without listening for the call that God places on each of our lives to respond to make God’s love real in the lives of others?

201 years ago, the people of Birmingham First didn’t know what it would mean to answer the call to bring Jesus to Piety Hill in a bar known as Willet’s Tavern, but they responded, nonetheless. And here we are today. They didn’t know that we’d grow to over 3000 people or that in spite of a pandemic, we’d still be 2700 members strong.

They certainly didn’t know that we’d be building churches in places like Costa Rica and Haiti. They didn’t know that we’d provide clean drinking water in Africa and Sneedville, Tennessee. They didn’t know that our youth choirs would travel back to England, the place of our Methodist heritage, and bring the gospel in music. I’m pretty sure that they never would have imagined having two campuses.

And yet, they answered the call to be here in this place; to give their all, come what may, for the people of their community and their world in their day so that somehow, by the grace of God, someone might be here to do the same today.

I’m not so sure that John and Nancy Smith knew entirely what might happen when they first reached out to bring mission teams to Haiti. They simply offered themselves, along with some others, believing that God had called us together, united as one, to make a difference following a devastating natural disaster. These past two years, when we couldn’t get on the ground, we sent supplies and resources.

Even better yet, one young man, who’s like a Haitian son to John and Nancy, gathered a group of friends to clean up the streets of his town. The Catholic bishop saw what they wanted to do and offered some supplies. That’s what happens when God’s people answer the call. Others join in the response and lives are transformed, communities are forever changed, and the world is never the same because of God’s grace at work among us.

The question is not whether God calls us today, but “How will we answer God’s call for the sake of the world?” As we answer God’s call, God uses us and what we offer in God’s name to positively impact our community and communities around the world, now and for generations yet to come.
