I hasten to share with you how grateful I am to serve as your senior pastor. In 201 years of ministry and mission through First United Methodist Church of Birmingham, Michigan, you have witnessed to your faith in Jesus Christ and have managed, by God's amazing

grace, to change lives for the better and to help make the world a better place. Many of you have stepped beyond the regular sacrifice of this great congregation to distinguish yourselves in generosity. Your generosity is rooted in gratitude for all God has done and is doing in your lives. Gratitude is a gift of God. We embrace gratitude, like the one leper in the Gospel of Luke 17: 12-19, who came back to thank Jesus Christ for healing him when nine others never returned to say, "thank you."

I want to share a story of my life and why I will forever be grateful.

On December 8, 1959, at the Methodist Mission hospital in Ganta, Liberia, two women met in the delivery room of the hospital. One was a pregnant Liberian woman ready to deliver her baby and the other was a Methodist missionary doctor assigned by the Methodist Board of Missions to the hospital. Dr. Hyla Watters had been assigned here after her first assignment in China ended following the emergence of the Chinese Cultural Revolution led by Mao Zedong.

Hyla grew up in the United States. As a little girl she felt God's calling to be a medical missionary to China. After she passed her medical board, she was commissioned and sent to China as a medical missionary. But her excitement was short-lived when she found herself on a plane back to America,

expelled by the communist regime. She struggled about her future vocation until other missionaries helped her understand that God's call can be fulfilled anywhere – that whenever one door closes, God will open other doors. With that understanding, Hyla agreed to go to Africa as a missionary doctor. She was assigned at the Ganta Methodist Mission Hospital, and it was there that she attended to this Liberian expectant-mother on December 8, 1959. After the woman delivered her child, she and her baby were released to go home. But on the way home, their pickup truck lost control and tumbled down a ravine to its bottom. Fortunately, although many passengers were wounded including the new mother, her baby was not hurt. The woman was taken back to the Mission Hospital, readmitted with her child, and treated by Dr. Watters. After a couple of days attending to her wounds, Dr. Waters released the mother and her child. This time, they made it safely to their farmhouse. And that was my first week in this world.

The work of Dr. Hyla Watters, who never thought she would serve in Africa, and her providential meeting with this Liberia mother, Mrs. Fannia Wannawon Boayue (my mother), made it possible for me to be born under safer health conditions. Dr. Watters' faithfulness to God's call in her life led to the safe birth of thousands of other children at Ganta. Without her and the sacrificial love of my mother, I wouldn't be here today to be grateful for all God has done and is doing in my life. I am grateful to God for giving me my mother and Dr. Watters.

Gratitude is God's good gift to the world. It helps us appreciate goodness and mercy. It rallies people of good faith and conscience to a higher calling, a greater purpose, and the common good. I join thousands of people whose lives have been changed for the better by the generosity of those here at Birmingham and Berkley First United Methodist Church to say, "thank you." Your investment in the promises of God will reap eternal fruits and will enable God's will to be done on earth as it is in heaven. I invite others to join in this worthy cause.

Letter from the

Endowment Chair

GRATITUDE



There are many definitions of "gratitude". One of my favorites equates gratitude with feeling grateful for something or someone in your life and responding with feelings of kindness, warmth, and other forms of generosity. It is this gratitude or gratefulness, I believe, that

has been the common precursor of nearly every gift to the Endowment Fund since it was first established in 1996. Those gifts have enabled Birmingham and Berkley First each year to undertake new initiatives, underwrite programs, assist youth trips and adult retreats, and so much more... all of which would not be possible through the Operating Fund.

The Bible has many stories of gratitude that we are familiar with. A few come to mind:

1. King Darius' officials were jealous of Daniel and convinced the Persian king to decree that anyone who prays to a god other than the King would be thrown to the lions. Despite the decree, Daniel continued his daily praying and giving thanks to God. Sadly, the king had to enforce his decree and Daniel was thrown into the lions' den. Yet God shut the lions' mouths and Daniel emerged the next morning not only alive, but without so much as a scratch. (Daniel 6)

- 2. Hannah was barren. She prayed and promised God if He gave her a son, she would give him back for lifelong service. Hannah kept her vow. Once weaned, she took Samuel to live with the priest in Jerusalem. She did not regret or resent her promise. Instead, she was deeply grateful and praised God. Though she loved Samuel she chose to worship the Giver, not His gift. (1 Samuel 1-2:2)
- 3. When Paul was imprisoned and put under guard on a ship for Rome, the ship was caught in a violent storm. For 14 days they saw neither sun nor stars and no one had eaten. They gave up all hope of being saved. That night an angel assured Paul in a dream that no one would die. The next morning, while the storm still raged, Paul took bread, gave thanks, and urged everyone to eat to regain their strength. The next day though the ship foundered and was lost all 276 on board made it safely to shore. (Acts 27:1-44)

We all have our own stories of gratitude. Like Daniel, may we offer gratitude to God no matter what we face. Like Hannah, may we offer gratitude to God for who He is over what He gives. Like Paul, may we offer gratitude to God, not after, but amid the storm.


In Memory

Steve Wells Legacy Celebrated

On September 11, 2022, Room 230 of the Lange Education Wing of our Birmingham Campus was rededicated in Memory of Steve Wells. The Wells classroom was recarpeted and repainted over the summer and a plaque now recognizes Steve's dedication as a Sunday School teacher. Steve was a volunteer Sunday School teacher for over 15 years and was actively teaching at the time of his too soon death in October 2019.

Steve's family has honored his legacy through the establishment of the Steven Wells Fund, a named endowment with the purpose of supporting discipleship ministries (Christian Education) for children and youth. This year, income from the Steven Wells fund is being used to purchase new furniture to provide needed updates in several Sunday School classrooms. We are grateful for Steve's legacy of faithfulness and for how his family has honored him, continuing that legacy for generations to come.

Susan and Claude Oleson Legacy Builders



Susan and Claude Oleson were invited to attend First Church by John & Liz Stevens. (Susan and Liz are both Speech Pathologists and are friends). At the welcoming luncheon after they were received as new members of the congregation (this was on April

4, 1982), Susan mentioned that Claude had seen in Steeple Notes that morning that they were looking for men to play slow pitch softball. And before that luncheon was over, Claude was a member of a church softball team! Thus began Claude and Susan's history of very active church membership!

Susan has served as a teacher in the Toddler Room, Bill Ritter's 3001 by 2001 committee, Ghana Mission Trip participate, Ghana Shanty leader (raising money for Ghanian women entrepreneurs, AIDS relief, and education for Ghanian orphans) and currently runs the Fair-Trade ministry (Claude is her assistant!). She has also been a leader with Church & Society ministries. Along with Claude, Susan has served as a lay delegate to Annual Conference.

Claude, an architect, served three terms on the Board of Trustees (President in 1996), two terms on the Endowment Fund Board, UMU liaison to the Ad Board, the sole male representative on COSROW, and as a member of the Worship Committee.

He was a member of the First and Second Floor Classroom Renovation (Lang Village) team, the Building Committee for the CLC, had a large part in the Sanctuary Renovation and was the church's representative (along with Zeno Windley) for construction of the South Wing Renovation. As a result, Zeno and Claude were recipients of the 2012 Volunteers of the Year award. Claude's professional expertise has been a gift to our congregation whenever the church has contemplated or undertaken construction.

After Bill Ritter retired as Senior Pastor, and became the Executive Director of the United Methodist Union, he invited Claude to lunch. At lunch Dr. Ritter invited Claude to become a board member. "We need someone who can read building plans". This led to Claude serving for 5 years as Vice President and 4 years as President of the Union. Claude continues to serve the United Methodist Union as a Life-Long Trustee.

Through Claude's service as a Trustee and Endowment Board member, Claude and Susan became very aware of the benefit to the church of an endowment. Claude was the Trustee President when our Endowment was officially chartered with a gift of \$175,000 in February of 1996.

During Claude's architectural career, he saw the deleterious effects of deferred maintenance on buildings. Claude's service with the Union provided more evidence to him of how critical it is to provide funding for building needs. In addition to named funds with specific purposes, endowed funds supporting continuing education; missions & outreach; worship & music; scholarships; children & youth; and buildings & grounds are available as

options to those committed to leaving legacy gifts. Because of Claude's experience both in the church and beyond, Susan and Claude's legacy gift (a tithe) is directed to our building and grounds endowment.

Bequest

Making a Bequest

Leaving Birmingham and Berkley First a bequest in a will or living trust is the most common way to create a legacy to support ministry and mission for generations to come.

Types of Bequests

There are several ways you can make a bequest to Birmingham and Berkley First.

Specific Bequest. A specific bequest involves making a gift of a specific asset such as real estate, a car, other property, or a gift of a specific dollar amount. For example, you may wish to leave your home or \$10,000 to Birmingham and Berkley First.

Percentage Bequest. Another kind of specific bequest involves leaving a specific percentage of your overall estate to charity. For example, you may wish to leave 10% of your estate to Birmingham and Berkley First.

Residual Bequest. A residual bequest is made from the balance of an estate after the will or trust has given away each of the specific bequests. A common residual bequest involves leaving a percentage of the residue of the estate to charity. For example, you may wish to leave 30% of the residue of your estate to Birmingham and Berkley First.

Contingent Bequest. A contingent bequest is made to charity only if the purpose of the primary bequest cannot be met. For example, you could leave specific property, such as a vacation home, to a relative, but the bequest language could provide that if the relative is not alive at the time of your death, the vacation home will go to Birmingham and Berkley First.

Bequest Language

To make a bequest, you should speak with you attorney. Your attorney can help you include a bequest to Birmingham First in your estate plan. As you work with your attorney, he may ask for the following:

The legal name for Birmingham First, which is The First United Methodist Church of Birmingham.

Our congregation's Federal Tax ID number, which is 38-1393844.


